### Eligibility:

- These incentives are available to residential customers with a valid River Falls Municipal Utilities electric account.
- There are no restrictions as to where the appliance is purchased.
- Appliance(s) must be ENERGY STAR rated. River Falls Municipal Utilities reserves the right to verify rating.
- Limit of one incentive per appliance per customer/utility account per year.
- Qualifying appliances include: clothes washer, refrigerator, freezer, dishwasher and dehumidifier.
- **The replacement refrigerator and/or freezer must be recycled to qualify.**

**Up to \$125 chamber check incentive is offered to encourage purchases of ENERGY STAR-qualified models. Receive \$25 chamber check when purchasing a clothes washer, refrigerator\* or freezer\*, dishwasher or dehumidifier.**

### How to Apply:

1. Purchase a new ENERGY STAR qualified clothes washer, refrigerator, freezer, dishwasher or dehumidifier by Dec. 31, 2017.
2. To qualify for an incentive, the applicant must meet all of the eligibility conditions and complete the incentive application on the reverse side.
3. Attach a copy of the sales receipt(s) or paid invoice(s) indicating the date of purchase, store name and product information.
4. Drop off your completed application at our office or mail it to River Falls Municipal Utilities at 222 Lewis Street, River Falls, WI 54022.
5. Receive chamber check in the mail.

## Refrigerator and/or Freezer Recycling Requirements\*

To qualify for the incentive for the purchase of the new ENERGY STAR qualified refrigerator or freezer, you must provide proof that the existing unit has been taken out of service and recycled.

- My old unit was recycled by the retailer delivering my new appliance, their pickup representative has signed below, and a copy of the proof of pickup documentation has been included with this application.
- I do not have appliances to recycle because this is a new construction home.

*I have picked up a refrigerator and/or freezer to be taken out of service and recycled. They will not be resold or reused.*
