2024 REBATE PROGRAM \$25 OR \$50 FOR RENEWABLE ENERGY PROGRAM PARTICIPANTS

Trees are a natural air filter, removing dust and greenhouse gases such as carbon dioxide while adding oxygen. When trees are on the south, east or west side of your home they can save you energy and money.

HOW TO PARTICIPATE

- Must be a River Falls Municipal Utilities (RFMU) customer and plant tree within the City of River Falls limits.
- Purchase tree anywhere in WI or MN.
- Call Diggers Hotline (800-242-8511) 3 days prior to planting tree
- Plant tree and take a picture. Submit your picture with this completed application and receipt to: mnooren@rfcity.org or mail to: **River Falls Municipal Utilities, 222 Lewis Street by November 1, 2024.**
- Incentive will be paid in the form of a River Falls Chamber Check. Processing time is 4-6 weeks.

PROGRAM INCENTIVE

- River Falls Chamber Check incentive is \$25 per tree or \$50 per tree if participating in a RFMU Renewable Energy Program.
- RFMU Renewable Energy Programs includes:
 - Green Blocks (\$2 per block per month)
 - Share of Community Solar
 - Rooftop Solar
- Three trees maximum.
- Incentive may not be greater than 50% of the total tree cost.
